Opportunity Race Levels

There are three (3) levels of support in the Ohio REALTORS-PAF Opportunity Race program.

Each level is generally defined by the amount of voter contact between Ohio REALTORS-PAF in support of the chosen candidate (or in opposition to the chosen candidate's opponent).

The level selected for each race depends on many factors but the two main qualifiers are: how good of a REALTOR supporter is the candidate, and how viable of a chance does the selected candidate have of winning the race.


GOAL: To positively affect the election outcome of Ohio REALTORS-PAF-supported candidates in competitive races.

Level 1	 4 Pieces Direct Mail Paid Phone Banks Targeted Social Media / Internet Ads Local REALTORS Education & Mobilization 	 Highly-competitive race (Ohio REALTORS-PAF staff performance index appraisal, etc.) Candidate champion of REALTOR public policy priorities.
Level 2	 2 Pieces Direct Mail Targeted Social Media / Internet Ads Local REALTORS® Education & Mobilization 	 Competitive race Candidate consistent supporter of REALTOR public policy priorities.
Level 3	 1 Piece Direct Mail Targeted Social Media / Internet Ads Local REALTORS Education & Mobilization 	 Minimally-competitive race Candidate demonstrated support of at least 1 of REALTOR public policy priority.

 - Direct candidate \$\$\$ contribution
 - Ohio REALTORS PAF support according to Opportunity Race Level schedule (Level 1 – 3)
- Contact Ohio REALTORS Public Policy Staff.
